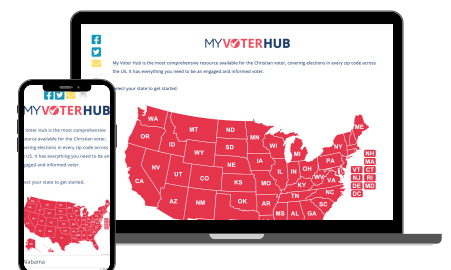

ACCEPTED FORMS OF VOTER ID

“Proof of identification” means a document that contains the name and photograph of the individual to whom the document was issued - and the document was issued by:

- The United States or the Commonwealth of Kentucky
- The United States Department of Defense, a Branch of the Uniformed Services, the Merchant Marine, or the Kentucky National Guard
- A Public or Private College, University, or Postgraduate Technical or Professional School Located within the United States
- Any City Government, County Government, Urban-County Government, Charter County Government, Consolidated Local Government, or Unified Local Government, which is Located within the State

OFFICES UP FOR ELECTION IN 2023

GOVERNOR	Chief executive of the state, commander and chief of the state's military forces, and empowered to enforce all state laws. Holds budgetary authority, veto power, the power to appoint administrative officials, legislative influence, crisis management, ability to grant pardons, clemency and commute sentences, among other duties.
LIEUTENANT GOVERNOR	The second ranking officer of the executive branch and the first officer in line to succeed the Governor.
STATE ATTORNEY GENERAL	Chief law officer of the Commonwealth of Kentucky and all of its departments, commissions, agencies, and political subdivisions, and the legal advisor of all state officers, departments, commissions, and agencies.
SECRETARY OF STATE	Commonwealth's Chief Election Officer, Chief Business Services Official, and chief advocate for civic engagement.
STATE AUDITOR	Ensures that public resources are protected, accurately valued, properly accounted for, and effectively employed.
COMMISSIONER OF AGRICULTURE	State executive position tasked with protecting and promoting the state's farming industry.
STATE TREASURER	Acts as chief financial officer and watchdog, ensuring that all state dollars are spent statutorily and constitutionally.
KENTUCKY GENERAL ASSEMBLY	House Representative District 93 will fill a vacant seat. Representatives perform lawmaking functions by researching, writing, and passing legislation.
SCHOOL BOARDS	Craft, review, and implement district policies, approve and oversee budgets, appoint, oversee and manage the superintendent, and serve as the final authority of the district.
COUNTY GOVERNMENTS	Various positions including justices of the peace, sheriff, county clerk, coroner, jailer, property valuation administrator, county surveyor, county attorney, constable, and, in counties that have adopted the commission form of government, county commissioners.
MUNICIPAL GOVERNMENTS	Operate under one of three models: mayor-council, commission, or city manager with mayor-council the most prevalent form. Generally ensure communities are well-managed and provided with essential public services such as public safety, law enforcement, infrastructure development, park and recreation services, and economic development.
