ACCEPTED FORMS OF VOTER ID

All photo IDs must have the following: An expiration date that has not passed, a photograph of the voter, and the voter's name (which must substantially conform to the voter's name as it appears in the Poll List or in the Poll Book).

<u>NOTE:</u> An unexpired Ohio Driver License, State ID Card, or Interim Documentation with your former address IS an ACCEPTABLE form of ID when your current address is in the Poll Book.

BALLOT MEASURES IN 2023

ISSUE 1

A Self-Executing Amendment Relating to Abortion and Other Reproductive Decisions — A "YES" vote would establish a constitutionally required extreme expansion of abortion rights, including removal of parental oversight when young girls are involved.

ISSUE 2

To Commercialize, Regulate, Legalize, and Tax the Adult Use of Cannabis — A "YES" vote would allow for the cultivation, processing, commercial sale, and use of marijuana for financial gain. Products can include concentrates, edibles, and extracts with no required safety procedures to mitigate dangerous potency levels.

OFFICES UP FOR ELECTION IN 2023

SCHOOL BOARDS

Act as the governance team for the school district, craft, review, and implement district policies, approve and oversee budgets, oversee and manage the superintendent, and serve as the final authority of the district.

MUNICIPAL GOVERMENTS

Ohio is a Home Rule state that grants municipalities a degree of local governance autonomy to pass laws to govern themselves so long as they obey the state and federal constitutions. City governments provide a variety of essential public services such as capital improvements, public safety and law enforcement, regulated land use and zoning, infrastructure development plans, as well as local taxation, park and recreation services, and economic development.

MUNICIPAL COURT CLERKS

Receive, collect, and issue receipts for all costs, fees, fines, bail, and other money payable to the office or to any officer of the court.

MUNICIPAL COURT JUDGES

Preside over civil, criminal, and traffic cases and conduct in both jury and non-jury trials and have the dual role of interpreting the law and determining the facts.
